





Filing an Amended or Modified Plan

- When filing a Modified Plan do not use NM LF 3015-2.
- If you make a selection that conflicts with the status of plan confirmation (i.e., plan confirmed and you select Amended), a warning will display.

When filing an amended or modified plan, you will be asked to make a selection:

Is the plan being Amended or Modified?

Notice of Adjustment

- If motions contained within the plan are not docketed, the Clerk's Office will not require refiling of the plan. The Clerk's Office will docket a utility event to ensure the requested relief is docketed.
- A Notice of Adjustment will be entered to inform the filer that the motion has been docketed and to provide instruction for future filings.
